8. New Business

- 8.1 Motion was made by Christopher and seconded by Watson to Approve Amended 2019-2020 District Calendar. Worth asked how this would affect this year Senior Class. Dr. Goble stated that is wouldn't affect them. Yea votes: Nichols, Christopher, Kirk, Spann, Watson, Worth, Hays
- 8.2 Motion was made by Spann, seconded by Nichols to Approve First Reading of the 2020-2021 District Calendar. Worth asked when graduation would be. Dr. Goble stated that graduation dates would have to be worked out with the venue but would likely be around 5/29/2021. Yea votes: Watson, Christopher, Kirk, Nichols, Spann, Worth, Hays
- 8.3 Motion was made by Spann, seconded by Watson to Approve First Reading of the 2021-2022 District Calendar. Yea votes: Worth, Christopher, Kirk, Nichols, Spann, Watson, Hays
- 8.4 Motion was made by Nichols, seconded by Spann to Approve Coaching Evaluation Timelines and Processes. Worth asked if evaluations had always been done on coaching staff. Dr. Goble indicated that it has always been done, but we are putting a timeline together so everyone knew what to except. Yea votes: Christopher, Kirk, Nichols, Spann, Watson, Worth, Hays
- 8.5 Motion was made by Christopher, seconded by Kirk to Approve Resolution Authorizing Student Disciplinary Action. Yea votes: Spann, Christopher, Kirk, Nichols, Watson, Worth, Hays
- 8.6 Motion was made by Kirk, seconded by Watson to Approve North Mac CUSD #34 Threat Assessment Manual (Plan). Worth asked how this would be distributed to staff. Dr. Goble indicated that after Board approval was given, we would ensure all staff had a copy of the manual. There is a possibility of updating the Threat Assessment team every year, but the law states who must be on the team. This is a new mandate that we had to comply with but is good because it gives us a process to go thru if there is a threat and how to reengage students coming back to school after a long suspension or expulsion for making threats.

- 8.7 Motion was made by Nichols, seconded by Christopher to Approve Bleacher Replacement Project for South Campus Main Gym. Dr. Goble reminded the board that \$50,000 of this will be paid for by a grant from the State. Kirk asked based on the drawing where the scoring table would go. The drawings indicate an exit aisle at half court where the scoring table should be. Discussion was had on what to do with aisle location. We will ask to have redrawn to put aisles similarly to where they currently are located. The board decided to table this item due to the issues with the drawing.
- 8.8 Motion was made by Christopher, seconded by Watson to Approve Bid for 2020 Chevrolet 2500HD Truck in the amount of \$43,021.90. Yea votes: Nichols, Christopher, Kirk, Spann, Watson, Worth, Hays
- 9. Superintendent's Report & Board Discussion Items
 - 9.1 Update on Baseball Field Project Dr. Goble wanted to thank Barn to Barn and Farley Cole for coordinating and moving the Greenhouse. Farley did a lot of prep work as well as getting volunteers to help with the project. There will be no bills for labor or materials but there might be inquires for documents showing donations for tax purposes. Dr. Goble reached out to Tom Hyde and Brian Dayton regarding the status of the Baseball field bids. Holland received drawing for bid packages and hoped to have bid packages put together by the end of this week. Dr. Goble is hopeful that at the next board meeting there will be bids to present.
 - 9.2 Discussion Item: Sports Activity Fees Dr. Goble recommends that the Board give serious consideration to doing away with sports fees. This could potentially help students participate in more than one sport. It would remove a barrier for students to be able to participate. There was discussion held regarding registration fees as well. Dr. Goble will be getting information together and reporting back to the Board.
 - 9.3 Dr. Goble let the board know the second reading policies will not happen until April to give the Board ample time to go thru all the policies.

Dr. Goble got a request from a community group to rent the new athletic facility. It is a baseball team who would want to do fielding practice. The Board needs to be thinking about what parts, if any, of the new athletic facility do you want to rent. Dr. Goble encouraged the Board to be thinking about this so it can made policy soon. Dr. Goble's research indicated that other schools with a similar facility rent for \$75-\$100 per hour. Questions the Board members posed were about supervision, liability, wear and tear, and custodial/maintenance costs. Dr. Goble stated that the plan was to unlock the facility for walkers in the morning but lock again once school started.

President Hays encouraged the Board members to attend the North Mac Foundation Dinner that was being held March 7th. The Foundation does a lot for the school and does recognize any Board member in attendance.
