How do the teachers feel about using this curriculum?

After doing some research on the Amplify CKLA curriculum I have some concerns.

Reports of teaching religion to very young students with bias towards Islam while Christianity is described negatively.

Are we now going to teach religion to elementary students or is that going to be scrubbed from the curriculum?

Other material is reported to have negative talk about law enforcement / border patrol, dead bodies, swear words in poetry and sexual descriptions.

Are these lessons and books containing this type of material used in lessons going to be scrubbed from the curriculum?

Critical Race Theory is a prominent component in many of the lessons.

For anybody that doesn't know what critical race theory is, it was brought about in the 1970's by a Harvard Law professor named Derrick Bell. It is a racist Marxist theory which basically breaks down everyone into groupsbased on their race into oppressed and oppressor classes. If you are of black or brown skin, you are oppressed if you are of white skin, you are an oppressor. Every aspect of society was set up by the oppressor to keep down and control the oppressed. When followed to its logical conclusion, CRT is destructive and rejects the fundamental ideas on which our constitutional republic is based.

Are we going to be in the business of teaching this racist ideology to our students or is this going to be scrubbed from the curriculum as well?
